Assessment #7: Praxis II Essay Test

1. Assessment Description

Every candidate seeking state certification in New Hampshire must pass the English Language, Literature, and Composition: Essays (0042) exam. NCATE does not require this test and the state of New Hampshire does not hold the ELA Program to a particular pass rate on this exam. However, the English department would like to see candidates achieve an 80% pass rate on the essays as they have on the Content Knowledge exam.

This exam consists of four essay questions that candidates must complete in two hours. The English Department tracks candidates' scores on this test very carefully because we see it as a reflection of our success in teaching our candidates to write. While we have respect for the composing process and the essential role revision plays in writing well, we also believe that English teachers ought to be able to write well spontaneously and to have enough grasp of sentence structure and grammar to do so in a way that demonstrates their control of language. This skill is crucial for making comments on student papers, answering emails from parents, or communicating with administrators and colleagues. In addition, an on-the-spot writing assignment has become part of some job interviews for teachers. It is a skill our candidates should have.

2. Alignment of Assessment with NCTE Standards

This test aligns with **Standard 3.1.7** concerning candidates' knowledge of grammar and with **Standard 3.5** concerning candidates' understanding and knowledge of literature. However, the English Department uses it to monitor **Standard 3.4** concerning composing effectively for a specific audience.

3. Data Findings

Our success rate for the essay portion of the Praxis has not been as high or consistent as we would like for it to be. Over the past three years, our pass rate has ranged from 100% to 50% to 80%. While most of our candidates meet the standards in most years, we will continue to strive to prepare candidates to pass these tests and to gain confidence in their ability to write spontaneously. Because candidates have reached an 89% pass rate on the Praxis II Content Knowledge exam, we assume the difficulty is with composition. The department is currently conducting writing assessments on which to base future curricular changes, and the Methods instructor is planning to conduct practice sessions on the essay questions as she does now with the multiple choice questions.

4. Evidence for Meeting Standards

Most candidates do pass this exam and therefore demonstrate their ability to read, analyze, and interpret literature; to use their knowledge of grammar; and to write well, meeting **Standards 3.5, 3.1.7, and 3.4.**

5. Assessment Documentation

5a. Assessment Tool

The test consists of four essay questions. The ETS website (<u>www.ets.org/Praxis</u>) describes these as:

- One literature question that asks examinees to interpret a work of poetry
- One literature question that asks examinees to interpret a work of prose
- One issue question that asks examinees to evaluate the argument and rhetorical features of a passage that addresses an issue in the study of English
- One issue question that asks examinees to take and defend a position on an issue in the study of English, using references to works of literature

- Lacks coherence or has serious problems with the control of language, including diction and syntax
